## Step #1: Identification

### **IDENTIFY VERIFICATION**

If the applicant needs to provide additional information to verify identity:

Documentation must include:	Document Examples and Tips:

## Step #2: Eligibility

## IF QUALIFYING THROUGH HOUSEHOLD INCOME

If the applicant qualifies through their income, they *may* need to show documents that their annual income is at or below 200% of the Federal Poverty Guidelines.

200% of the federal poverty level: Family of 1: \$25,760; Family of 2: \$34,840; Family of 3: \$43,920; Family of 4: \$53,000; Family of 5: \$62,080

Documentation must include:		Document Examples and Tips:
•	Your (or your dependent's) first and last name	Prior year's state, federal, or Tribal tax return (e.g. a 1040)
•	Your annual income	Current income statement from your employer or a paycheck stub (note: you will need this for three consecutive months)
		A Social Security statement of benefits
		<ul> <li>Veterans Administration statement of benefits</li> </ul>
		Unemployment or Worker's     Compensation statement of benefits
		Divorce decree, child support award, or a similar official document showing your income
		A retirement/pension statement of benefits



### IF QUALIFYING THROUGH ASSISTANCE PROGRAM PARTICIPATION

If the applicant (or dependent) participates in one of the qualifying programs, they may need to provide a letter or official document as proof.

#### **Documentation must include:**

- Your (or your dependent's) first and last name
- The name of the qualifying program, such as SNAP
- The name of the government, Tribal entity, program administrator, school, school district, university, or college that issued the document
- An issue date within the last 12 months or a future expiration date
- For the Free and Reduced Price School Lunch Program or School Breakfast Program, documents can be from either the 2019-20, 2020-21, or 2021-22 school year
- For Community Eligibility Provision (CEP) schools, documents must show that the student is enrolled in a CEP School for the 2019-2020, 2020-2021, or 2021-2022 school years. Acceptable documentation includes a report card that shows the student's name, school name, and school year, or a letter from the school confirming the student is enrolled in the CEP school. The enrollment letter must show the student's name, the relevant school year, the name and address of the school, and contact information for the school
- For Federal Pell Grants, documents should be from the current award year and can include screenshots of a StudentAid.gov dashboard

### **Document Examples and Tips:**

- Benefit award letter
- Approval letter
- Proof of enrollment in a Community Eligibility (CEP) School- this can be a letter from the school or a student's report card
- Free and Reduced Price School Lunch Letter
- Statement of benefits
- Benefit verification letter
