OUR PRIMARY ACTIVITIES FOCUSED ON BUILDING A ROBUST PUBLIC-PRIVATE PARTNERSHIP WITH STATES, CITIES, AND OVER 3,000 PARTNERS, INCLUDING COMMUNITY-BASED ORGANIZATIONS, INTERNET SERVICE PROVIDERS (ISPS), AND TRUSTED INSTITUTIONS, TO ACCELERATE ACP AWARENESS AND ADOPTION. LEVERAGING TOOLS LIKE GETACP.ORG AND OUR MARKETING SUPPORT, THESE PARTNERS CONNECTED 4.6 MILLION PREVIOUSLY UNCONNECTED HOUSEHOLDS - LIFTING THEM OUT OF THE DIGITAL DIVIDE.
